Weekly Dues

Dues Increase

Weekly dues will be going up \$5.00 per team next session.

Weekly dues for Ladies and Double Jeopardy & Masters leagues will not be affected by this increase.

DIVISIONAL PLAYOFFS -

If any team would like to play their Division Championship Match (2nd week of playoffs) in their area they may **BUT** they must do the following. The teams **MUST NOTIFY THE OFFICE THAT YOU ARE PLAYING IN YOUR AREA.** **You must call 888-APA-POOL & get the name of the person you speak to in the office. You can e-mail us also but you need to make sure you get a confirmation e-mail in return.** The match must be played within 2 days of the 1st week of playoffs because the Qualifier Cups start the weekend following playoffs for the Spring Session.

BOTH teams have to agree to play it in your area instead of at the qualifier cup. The winning team must fax in both score sheets and then mail both score sheets along with the weekly dues for both teams. The winning team then must call the office to find out the time of their first match at the Qualifier Cup. We appreciate your understanding with the time constraints for the Spring Session.

Playoff Format

Divisions with 4 teams
1st vs. wildcard – advance to tier 2

Divisions with 5 teams
1st vs. wildcard – advance to tier 2
2nd vs. 3rd – advance to tier 2

Divisions with 6 or 7 teams
1st vs. wildcard – advance to tier 1
2nd vs. 3rd – advance to tier 1

Divisions with 8 or more teams
1st vs. wildcard – advance to tier 1
2nd vs. 3rd – advance to tier 1
4th vs. 7th – advance to tier 2
5th vs. 6th – advance to tier 2

Eligibility – Players must play 4 times with your team during the session to be eligible for playoffs. Players must have 6 scores overall to be eligible for Qualifier Cups. It is your responsibility to make sure all players get the required number of matches. Don't wait till the end of the session in case you end up with a forfeit or bye. Players must have 4 matches during the session and 10 overall for the State Tournament. Please read the rule book, with special attention given to pages 81 to 91, Higher Level Tournament Eligibility Information & Rules.

There are no exceptions to the eligibility rules. Make sure you players get the required number of matches during the session.
