2 MATCHES AWAY FROM VEGAS.....

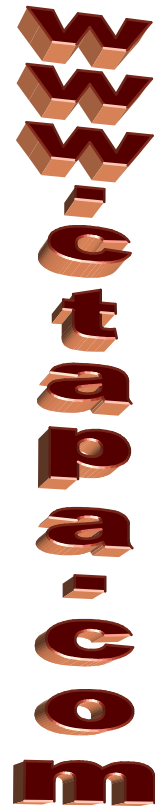
