Playoffs/Qualifier Cup

OFFICE HOURS

August 30th – September 20th

There will be someone working in the office until 8pm to answer playoff & 1st week of play questions.

If any team would like to play their 1st round of the Qualifier Cup in their area they may BUT they must do the following.

The teams **MUST NOTIFY THE OFFICE THAT YOU ARE PLAYING IN YOUR AREA. YOU MUST PLAY WITHIN 2 WEEKS** of the 1st week of playoffs. BOTH teams have to agree to play it in your area instead of at the qualifier cup. The winning team must fax in both score sheets and then mail both score sheets along with the dues for both teams. The winning team then must call the office to find out the time of their first match at the Qualifier Cup.



Make sure your team is current on all League Fee's.....

If your team is behind on weekly league fees you will not be allowed to be in the wildcard draw and may be completely removed from playoffs. If your team is behind make a concerted effort to catch up, as there are only a few weeks left of regular play.

What is a Rule 8? When a team is behind on their weekly league fees we will ask the opposing team to collect their payment from them before the match begins. If payment isn't made then the match isn't played and the non-rule 8 team will receive forfeit points.

What if I am not comfortable collecting money from my opponent? If you do not feel comfortable collecting the Rule 8 money you just need to call our office and let us know. We will ask a division representative or an area manager to collect the money. We just ask that you please call us at least a day before the match so that we will have time to contact the appropriate parties.

What if my opponent tells me they have already paid? If a Rule 8 is paid in the office, we contact the captain of the opposing team to call it off; if you did not receive a call from us, you should not play. You may contact your division representative to verify that the Rule 8 has or has not been called off.

To register your team you can fill out the registration form attached to your score sheet or you can just check yes at the bottom of your score sheet.

Eligibility for Playoffs & Qualifiers

In order for a player to be eligible for Playoff matches they must play 4 matches during the current session. To play in the qualifier cup they would need 6 matches overall including the 4 during the session. **The summer session is the shortest session make sure all your players get the required number of matches.**
